### Eligibility Requirements

Please only complete the application form if you **fully** meet the eligibility required by the Government of Prince Edward Island as follows:

- **Applicants cannot receive PEI Social Assistance** (if you are please contact your financial caseworker for support)
- **Applicants must meet income criteria**
- **Applicants must be facing hardship in meeting home heating expenses**
- **Applicants must be a Canadian Citizen or a Permanent Resident of PEI (Have a PR CARD)**

Canadian citizens or permanent residents, where Permanent Residency Status means: a status granting someone who is not a Canadian citizen the right to live and work in Canada without any time limits on length of stay. Permanent residents have the right to get most social benefits that Canadian citizens receive, including health care coverage, have the right to live, work or study anywhere in Canada; have the right to apply for Canadian citizenship; and have the right to protection under Canadian law and the Canadian Charter of Rights and Freedoms.

- **Single Person Household ..... \$45,000 or less**
- **Family Household ..... \$60,000 or less**

Where income is defined as gross income (Line 15000 of Notice of Assessment)

**Applicants will be expected to produce proof of income, Lease Agreement, proof of address and fuel expenses.**

**To apply, please submit the following:**

- Lease Agreement** (if renting).
- 2025 Notice of Assessment** required for all individuals in the household over the age of 18 showing gross income on line 15000
- Heating Bill** for the primary heat source showing:
  - The supplier
  - The account number, name and address of the applicant
